### “Spring and Croquet is Nearly Here!”

Welcome to the second newsletter of 2011 as we look forward to longer and warmer days and the start of our playing season after the very cold winter. The courts are looking good and have benefited by the good work from the Town Council ground staff over the winter months. As long as we don't get too much wet stuff over the next week or so we hope to be able to stick to our scheduled opening date of Saturday 26th March - however as per last year if there is any delay caused by unforeseen circumstances then we will endeavour to let everybody know as soon as possible via email and/or telephone - so check your emails daily as we get nearer to the 26th March.

### License Agreement with Leighton-Linslade Town Council - Security of Tenure - Court Maintenance - Fund Raising and Membership

Members who attended the AGM and who read the first newsletter of 2011 will have been brought up to date as to what had been a momentous 2010 behind the scenes, during which Tom Miller and Richard Keighley were involved in complicated and far reaching meetings with the Town Council concerning the future of our club.

The draft License approved by the membership at the AGM was agreed by Leighton-Linslade Town Council Leisure and Community Committee (L&CC) at a meeting attended by Tom Miller on 14th February - hopefully an appropriate date! Tom is to be congratulated on his excellent presentation to the meeting describing our Club's foundation and activities, followed by the reasons for the formulation of the License. His words are appended to the end of this newsletter and all members are requested to read this as it clearly defines the current and future ramifications for the Club and members.

The License was signed by the Club's three authorised signatories, David Ball, Len Buckingham and John Cundell on 2nd March, then by the TC representatives on 7th March and passed over to Chairman David Ball by the LLTC Town Clerk Pat Kingsnorth on Tuesday 8th March.

The security of tenure for six years is obviously welcome, but as Tom stated, it also gives us the opportunity to look at further development of the courts as awarding bodies look for some certainty of the longevity of investing in our sport.

The fact that we are now responsible for the court treatments - fertilising, weed killing, scarifying and the like - and white lining the marking out of the courts (not the mowing and watering as this will still be handled by the Council), means that we will have to find ways of increasing our revenue. There are a number of innovative proposals in the pipeline which will be outlined to members in due course.

Of course the most beneficial method of raising revenue is to find more members! We will endeavour to obtain some

local press publicity both in 'News from The White House' and the local press by reporting on the new License handover; and the Official Opening on 3rd March by the Town Mayor. Also we will be holding our Come & Try day later in the season - 27th August and possibly also the 29th August - Bank Holiday Monday. In the past these C&T days have been early in the season when the weather is not so good, and also it is a substantial commitment to take out a yearly subscription based on a few hours of play. At the end of August the weather and timing may be better, and we could offer interested visitors the chance to join and play during September for a reduced fee, and with luck they will stay with us for 2012.

From reports we have received from a variety of sources, there seems to be a rumour around the area that we have a waiting list for membership. **THIS IS NOT THE CASE.** Please advise anyone you hear making this erroneous statement that we are actively looking for new members.

The only provisos are that a) if the Council Ground staff or any Contractors we employ are working on the lawns, then they will have priority and members will have to wait until they are finished; and b) certain Mondays and Fridays when League and Friendly matches are scheduled when no club play will be possible.

### Golf Croquet Improvers Coaching

Richard Keighley is organising a Golf Croquet Improvers Coaching day on Monday 6th June at Page's Park. This will be open to both LL members and local clubs. There will be a charge of £10 per applicant - tea/coffee and biscuits provided but bring your own lunch. Initially, LL club members interested should apply to John Cundell. Please note that places will be offered in the first instance to players who did not take part in last year's course. The idea of the course is to expand the pool of players who might participate in Friendlies, League and outside tournaments. Those who took part last year will be placed on a reserve list.

## Inter-Counties Tournament

This is a new event and is a team competition between the six counties comprising the EACF, taking place over a single day and including singles and doubles games for all players at level play. The six counties are Beds., Essex, Herts., Norfolk, Suffolk and an EACF Select team led by Terrey Sparks as Cambs. is not able to field a team. Each county team will comprise four players with a total team aggregate handicap of not less than 8. The Team Captain for Beds. is John Cundell. Players must either be born, reside or be registered with a club within Beds., plus the addition of Northampton and Stony Stratford clubs. The tournament will be at Hunstanton CC on 11th June. There will be an entry fee of £26 per team. Any members wishing to be considered are asked to give their name and handicap to John Cundell.

## Club Handicap Events

Members will recall that it was agreed for 2010 that all members who wish to take part in Club Handicap competitions must have played at least 10 handicap games, preferably against a variety of players, in the available sessions prior to the competitions. This policy will continue into 2011 but should not cause the problems that arose in 2010 as most interested members completed their required number of games in 2010.

Also, Hunstanton CC is hosting the second Under 21 Golf Croquet World Championship from 12-15th July - which is the reason our Friendly with them has been moved back two weeks. The Championship will also serve as a qualifying event for the WCF Bestinvest Golf Croquet World Championship the following week at the Hurlingham Club. The two highest placed finishers in this event, who are available and who have not already gained places for the GC World Championship, will each be awarded a place in the GC World Championship. From the information above it sounds like a visit to Hunstanton during the week may be worthwhile to watch some of the action - and/or to Hurlingham the following week.

To all those who have served: from the scorers and their manager to the players in league and friendly fixtures; from the Fixtures Secretary to the Fun Day organiser; from the General Committee to the Membership Secretary; from the Quartermaster to the Catering Manager and all the ladies who produce those wonderful cakes and last, but definitely not least, from my predecessor Chairmen to those who, time after time, turn out early to set up gazebos and set out the courts etc. so that the rest of us can enjoy ourselves. Thank you!

### **Tom Miller's Address to LLTC L&C**

Chair, Councillors.

My name is Tom Miller and I am Immediate Past Chair of the Leighton-Linslade Croquet Club. I have, of course, addressed the Committee twice before on the subject of the hire of Page's Park pavilion for a Social Club, run by the Croquet Club. However, this evening I am here on a totally separate matter, namely to commend to you the proposed licence between the Town Council and the Croquet Club - item 15 on your agenda.

The Croquet Club was founded in 2000, with the encouragement and agreement of LLTC, with 35 founder members playing on two undersize lawns in Page's Park. Since then, we have been extremely fortunate in the support the Council has afforded us, for which we are most grateful, and we now have nearly 60 members and three full size courts.

For our part, we have contributed nearly £10K to the Council, in rentals and donations, and have put Leighton-Linslade on the croquet map.

We play a version of croquet known as Golf Croquet, which is fully recognised under The Croquet Association, of which we are members. Indeed, last year, two of our members updated the official guide to Golf Croquet, as published by the Association, and one of our members was awarded the Croquet Association Diploma for his contribution to the sport.

We field two teams in the East Anglian Croquet Federation's League. In 2005, we won the League and missed out, last year, by just one hoop in the season long campaign. In 2009, we reached the national final of the Inter Club Plate competition. Unfortunately, we lost to our old rivals Letchworth. However, in the brief speeches afterwards, their chairman said that LLCC is a beacon in the region in respect of membership numbers, the support and enthusiasm of members and general development of the Club.

Two of our members have been recipients of the Leighton-Linslade District Sports Council's Service to Sport awards.

Whenever we are playing and the Leighton Buzzard Railway is operating, you will find members enthusiastically waving to passengers, who reciprocate, just as we specifically made sure we did, resplendent in our "whites", for the judges of Anglia in Bloom.

Until now we have used the courts at Page's Park on a season - that is March to October - by season basis. This lack of security of tenure is now likely to limit the Club's further development, as awarding bodies, including The Croquet Association, look for some certainty of the longevity of, what they see as, investing in our sport.

Hence, we are seeking to formalise what has been the historic situation but with some significant changes, which are to the Council's advantage. During the negotiations with the Council Officers, they indicated that the Council would be looking for cost efficiencies. Therefore, the Club has offered to take over responsibility for the lawn treatments - fertilising, weed killing, scarifying and the like - and white lining the marking out of the courts. However, and significantly, we have offered to maintain the same fee structure based on last year's sum. Your revenue remains the same and increases by 5% per annum, while the Club takes on costs you have previously paid.

This will not be straight forward for us. With a membership whose approximate average age is 72, we do not have a totally elastic market and will have to be innovative with ways of increasing revenues. But we are up for the challenge!

In conclusion, this is, as they say, a win-win proposal. The Croquet Club gets up to six years security of tenure and can continue to play its sport in the town. The Council gets the same revenue, including yearly increments, with less input to the maintenance of the lawns.

In closing, I must pay tribute to the input of the Council Officers.

Chair, Councillors - I commend the proposed licence to you and trust you will agree to it being implemented. Thank you.

# Health and Safety Risk Assessment - version 4 at 24th February 2011



**Method of assessment:** Overall risk is assessed as a combination of the Likelihood (L) x Severity (S) to arrive at the Rating shown.

L is assessed with ratings of: 1. Low or seldom; 2. Medium or frequently; 3. High - certain or near certain.

S is assessed with ratings of: 1. Minor - cuts or bruises; 2. Medium - serious injury; 3. High - fatality or serious injuries.

The resulting Risk Rating factors are then categorised as: from 1 to 3 - low priority; from 4 to 6 - medium priority; from 7 to 9 - high priority.
