- 4. Matters Arising:

It was agreed to offer reduced subs from 13th June on same basis as last season.

10. Plans for the Future of Club.

The provisional consensus was that it was sensible to allow a small surplus to accumulate each year for the following reasons :

- a) the possibility that it would cost more to hire the existing lawns.
- b) the uncertainty as to whether a contribution would be required from the club, if a 3rd lawn was provided.
- c) the purchase of new equipment.

If the Council were to provide a new lawn at ratepayers' expense, it would obviously charge the club to use it. Hire charges would be expected to rise possibly from £800 to £1200, or £1500.A membership of 35-40 could not bear such increases and there was no present indication that a membership of 60 plus was achievable.
