2. Apologies J. Slow, R. Keighley
3. Minutes of 22.4.02 Agreed with no corrections
4. Matters Arising
 - a) Wrest Park Mallets: A. Bunn to return them via Martin Field
 - b) May Fayre / Jubilee: These events were very successful. It was agreed that a letter of thanks be sent to Joan Slow for the wonderful props (flamingoes and hedgehogs) she had produced.
 - c) Under-age children: L.B. is still awaiting response to his enquiry from our insurance company. The children originally discussed have not appeared this season.
 - d) First-aid supplies: After discussion it was agreed to accept E. B's offer to arrange for a suitable selection.
 - e) Urn: L.B. has obtained a second kettle and, as an urn would only be necessary about twice a year, it was agreed not to follow this up.
 - f) Keys: Some new members may need keys whilst some ex-members still have theirs. L.B. will possibly ask the Jones' for theirs unless they intend to re-join shortly. M.D. returned hers as she finds the shutter too heavy to operate. N. Brett has not re-joined yet but has a key.

 - a) Correspondence
 - i) Thanks were received from the Mayor, from Table - re May Fayre and Town Council - re Jubilee.
 - ii) I. Davis had been given a letter and visited re the return of her m. fee "of no evening sessions. She has resigned membership.

 - iv) John Bevington had offered that our club members who wish to use Wrest Park group membership could attend and play. M. Brown holds the L.L.C.C. group key. Fee for group membership to their treasurer.
 - v) All sick members had been contacted and their condition reported to committee. Judy Anderson also contacted.

 - vii) The club has been invited to S. Backs consultation on "Sports Development". M. Dilley agreed to attend the meeting.

b) Grant Application - had been handed to chair of L.L.S.P.C. Council but subsequently 'lost'.

c) L. had written a letter about the vandalism etc. at Fingers Park to L. Hindson and asking that our fee be reduced by up to half its present rate in view of our loss of membership/use of the lawns. It was agreed that this be sent on Club paper by the treasurer.

7. Future Events: Friendlies. M.D. to fix a date with Dunstable U3A group (R. Richardson) and to contact Edmée Robinette re possible visit to Bury St Edmunds Club.

Tournaments. A. Bunn reported that 4 people were entered for the Nat. Trust at Anglesey Abbey and she had submitted 5 names for the Ticknall singles event. Grass Roots It was reported that I. Davis was not, after all, submitting a team for this tournament. A. B. to enquire if it is possible to enter a team of 8 from our club this year. Agreed the club will underwrite any shortfall in entry fees. Regional heats will be in July/August, final at Solihull on 8th Sept.. It was further confirmed that we should enter the competition next year as L.L. club.
